### LUNAM CONSTRUCTION COMPANY

TABLING OF RETURNS TO QUESTIONS

Hon. Alphonse Fournier (Minister of Public Works): Mr. Speaker, I wish to table reference No. 174, mover Mr. Diefenbaker: How many building or repair contracts have been granted to the Lunam Construction Company, Saskatchewan, since January 1, 1948;

Also reference No. 154, mover Mr. Diefenbaker: Correspondence between any department of the government and the Lunam Construction Company of Regina, having to do with failure to complete its subcontracts;

Also reference No. 215, mover Mr. Coldwell: Copy of progress reports signed by dominion public works architects, Saskatchewan, in connection with contracts awarded to the Lunam Construction Company of Regina.

This is only a partial report, relating to the Indian hospital at Fort Qu'Appelle. My officials have worked ever since the return was passed in the house to prepare these progress reports, and to have copies photographed and tabled. I had the pleasure of showing the originals to the hon, member for Rosetown-Biggar, and I asked him if he wished to have my officials continue working on these progress reports for all the other contracts, because I do not know if there would be any possibility of tabling them before the end of the session.

Mr. Coldwell: The minister has stated what is correct. I saw the other reports and I think if this one were tabled it would give an indication of the type of report it

Mr. Fleming: May I ask the minister if he is willing that these reports be referred to the public accounts committee for inquiry.

Mr. Fournier (Hull): I have absolutely no objection.

#### REGULATIONS ACT

REPEAL OF SECRECY PROVISION RESPECTING ORDERS IN COUNCIL

Mr. Stanley Knowles (Winnipeg North Centre) moved for leave to introduce Bill No. 365, to amend the Regulations Act.

He said: Mr. Speaker, the purpose of this bill is to repeal the section of the Regulations Act, enacted in 1950, which gives the government the power to pass a regulation keeping secret any order in council, whether under the Emergency Powers Act or any other statute, which the government wishes to withhold from publication.

This bill would not affect any order now in effect, but it would prohibit the passing of any further secret orders in council under the Emergency Powers Act or under any other statute now in operation.

Motion agreed to and bill read the first time.
