We are anticipating that the Minister of National Defence will soon name a review authority to lead the second five year review of the National Defence Act. The Military Police Complaints Commission (MPCC) will seek to make submissions on Part IV of the National Defence Act, our governing legislation as we did for the first five year review carried out by the late former Chief Justice Lamer. As part of this review, we will be making proposals which we think will better the complaints process and make it more efficient and effective. Some of these proposals relate to ensuring that the MPCC has adequate access to the necessary documentation to carry out its mandate and ensure that we have all the necessary information before us to properly make findings and recommendations in relation to conduct and interference complaints.
